Carefully add 2-3 cups of HG Liquid Drain Opener to the toilet water and allow to activate for at least 30 minutes, then flush. In stubborn cases, fill toilet with hot water, add 2-3 cups of HG Liquid Drain Opener and leave to activate overnight before flushing. To clear organic matter only, the slower but biological HG (Kitchen) Enzyme Drain Unblocker may be used also.
