DIRECTIONS FOR USE

The surface to be treated should be dry, clean and free from dust. Before applying the product, ensure all of the above. Apply the product in a thin layer by using a paintbrush or roller. Allow to dry fro 8 to 15 minutes before removing residue. If . necessary apply a second coat. To achieve a slight gloss, buff with synthetic white pad. Do NOT use on sealed, glazed, polished or non-absorbtive surfaces. Allow good ventilation. **Do NOT over-apply. In case of over-application use solvent painstripper with DCM (Dichloromethane & Methanol).**

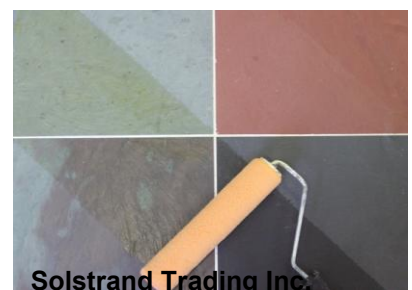
